**BIOGRAPHICAL SKETCH**

Robert Augustus Barnes—grocer, commission merchant, bank president, stockholder, property owner, and philanthropist—was born November 29, 1808, in Washington, D.C. His father, Jesse, died when he was thirteen years old, at which time he moved to Louisville, Kentucky, to be raised by his uncle Richard Barnes. He supplemented his rudimentary education with extensive reading, and became knowledgeable in several subjects. After working as a clerk for two years, he moved to St. Louis in 1830, and took a position in a mercantile house. At twenty-three years old, he opened his own grocery and commission business. While a merchant, he held partnerships with John W. Reel, Antoine S. Robinson, John C. Swon, George Sproule, and Anaw Buchanan.

In the early 1840s, Robert Barnes became president of the Bank of the State of Missouri, a position which he held for twenty-six years. He also held executive positions in other local companies, including the St. Louis Railroad Company. In addition, he was a large stockholder in various local companies, including Belcher's Sugar Refining Company, Third National Bank, and the St. Louis Railroad Company.

On January 28, 1845, Robert Barnes married Louise DeMun, the third daughter of Jules and Isabelle Gratiot DeMun. They had two children, De Mun and Isabelle Gratiot, neither of whom survived infancy.

Although he was a successful businessman and capitalist, he kept his financial status private during his life. He contributed to several charitable organizations, and left a portion of his wealth to found and endow a hospital in his name. He also owned property in St. Louis, Missouri, Illinois, Iowa, and Wisconsin. He left his fortune in cash, convertible securities, stocks, bonds, and property.

Robert Barnes died April 2, 1892, in St. Louis and is buried in Bellefontaine Cemetery.

John W. Reel was a businessman, stockholder, officer, and property owner. In 1836, he joined with Robert Barnes and Antoine S. Robinson to form Reel, Barnes and Company. He also formed a partnership with Julius Vairin of New Orleans, known as Vairin and Reel. This company liquidated in 1837 due to slow business. In January 1937, he became president of the Marine Insurance Company. He owned property in Warren County, Illinois.

John Reel committed suicide on January 6, 1838. He was survived by his wife, Eugenie, and four children: Harriet V., Mary S., John H., and Arabella. Reel also had a brother, Julius Reel, of Julius Reel & Company of New Orleans. Robert Barnes was the administrator of Reel's estate. In 1866, he finally closed the business of Vairin and Reel, and was discharged from its affairs.

### **SCOPE AND CONTENT NOTE**

The collection, which consists of personal, business, and family papers of Robert A. Barnes, is arranged in the following five series: **Robert A. Barnes Personal Papers Series, Business (Grocer and Commission Merchant) Papers Series, Stockholding/Executive Papers Series, Barnes Family Papers Series, and John W. Reel Estate Papers Series.**

The **Robert A. Barnes Personal Papers Series**, which is the largest series, contains Barnes' personal papers, including correspondence of family and friends; bills and receipts for goods and services incurred through daily living; legal papers; tax bills and receipts for St. Louis City and County, Illinois, Wisconsin, and Iowa Territory; insurance policies and receipts; personal accounts; and papers regarding Barnes' estate. This series also includes correspondence relating to Barnes' position as an alleged Southern sympathizer during the Civil War. The **Robert A. Barnes Personal Papers Series** is divided into the following eight subseries: Correspondence; Bills and Receipts for Goods and Services; Legal Papers (which is subdivided into wills, claims, deeds and leases, and miscellaneous legal documents); Tax Documents; Insurance Policies and Receipts (which is subdivided into policies and receipts); Personal Accounts; Robert A. Barnes Estate; and Miscellaneous.

The **Business (Grocer and Commission Merchant) Papers Series** consists of papers relating to Barnes' business as a grocer and commission merchant in St. Louis. This series includes business correspondence, bills of lading, shipping invoices, business partnership agreements, and papers of Reel, Barnes and Company. The **Business (Grocer and Commission Merchant) Papers Series** is divided into the following seven subseries: Business Correspondence; Bills of Lading (which is subdivided into "shipped to Barnes" and "shipped by Barnes"); Shipping Invoices; Business Receipts of Items Shipped, Weighed; Business Partnership Papers; Papers of Reel, Barnes and Company; and Miscellaneous Business Papers.

The **Stockholding/Executive Papers Series** documents Barnes' stockholding interests in various St. Louis companies, including the St. Louis Railroad Company, Laclede Railroad Company, Belcher's Sugar Refining Company, and St. Louis Shot Tower Company. This series also contains correspondence and printed materials of the Bank of the State of Missouri, of which Barnes was president. During Barnes' tenure with the bank, he closely followed the war between banks and savings institutions in the 1850s, as is evident through correspondence and newspaper clippings in this series. The **Stockholding/Executive Papers Series** is divided into the following six series: Correspondence; Banks (which is subdivided into the Bank of the State

of Missouri, Bank of Kentucky, and Third National Bank); Railroads (which is subdivided into St. Louis Railroad Company, printed matter, and Laclede Railroad Company); Belcher's Sugar Refining Company; St. Louis Shot Tower Company; and Stock Papers.

The **Barnes Family Papers Series** contains papers of the family of Robert A. Barnes, including his brother William Barnes and Barnes' relatives by marriage, the Chenie family (Antoine, Therese and Julia). This series is divided into the following two subseries: William Barnes Papers and Chenie Family Papers.

The **John W. Reel Estate Papers Series** consists of papers relating to the estate of John W. Reel, of which Barnes was the administrator. These papers include papers of John W. Reel, Julius Vairin, the business of Vairin and Reel, and the administration of the estate. This series is divided into the following five subseries: Papers Regarding the Administration of the Reel Estate; John W. Reel Papers; Julius Vairin Papers; Vairin and Reel Papers; and Miscellaneous.
