BIOGRAPHICAL SKETCH

Julius H. Gerhard and his wife, Elizabeth, had three children, all of whom were born in Missouri: Albert J. (born March 17, 1855; died September 8, 1917, in St. Louis), Clara (born circa 1862), and Julius W. (born February 24, 1871; died December 24, 1946, in St. Louis). Albert J. Gerhard spent some time in Leadville, Colorado, and Kingston, New Mexico, in the mining business. Julius W. Gerhard served as a lieutenant in the Spanish-American War, and was a member of the Missouri National Guard for several decades.

SCOPE AND CONTENT NOTE

Papers include letters of Albert J. Gerhard to his family and other family papers.

- 1884 Aug 2 Letter signed Albert [Albert J. Gerhard], Denver, Colorado, to Pa & Ma. Mentions his arrival in Denver, discusses the mining business, and asks his parents to write to him at Leadville. Accompanying envelope is addressed to J.H. Gerhardt, Bates & Taylor Aves., St. Louis, Mo. Letter is written on the stationery of the Windsor Hotel (Denver). Letterhead and accompanying envelope include an image of the hotel.
- 1886 Oct 13 Fragment of unsigned letter [in Albert J. Gerhard's handwriting], Kingston, New Mexico, to "Dear Clara." Discusses mining business.
- 1892 May 18 Letter signed Albert [Albert J. Gerhard], St. Louis, to "Dear Folks." Describes the effects of the flood in St. Louis and East St. Louis, discusses his business, and mentions several acquaintances in St. Louis. Letter is written on the letterhead of the Granite Mineral Wool Co. (108 North 9th), formerly the Standard Mineral Wool Co. (office at 1240 Collins St., works at Koeln Ave. and Oak Hill Railroad).
- 1897 Nov 15 Promissory note signed Julius H. Gerhard, St. Louis, Mo., to pay the German-American Bank. Stamped "Paid, December 22, 1897."
- 1897 Dec 20 Promissory note signed Julius H. Gerhard, St. Louis, Mo., to pay the German-American Bank. Stamped "Paid, March 23, 1898."
- 1901 Dec 2 Letter signed Chas. W. Barstow, Jr. [Charles W. Barstow, Jr.], Hillman Land & Iron Co., Grand Rivers, Kentucky, to Capt. J.W. Gerhardt, commanding Company G, 1st Missouri Infantry, St. Louis, Mo. Mentions that he has enclosed letters and papers from Mrs. J.A. Wilburn. "I have written Mrs. Wilburn that I have turned this over to you as you were in command of the company during my sickness in Chattanooga at which place Wilburn claims to have contracted his illness."
- 1914 Mar 2 Note signed E. Gerhard, 4521 Duncan Ave. [St. Louis], to Perkinson Cons. Co. [Perkinson Brothers Construction Company]. Encloses check for reconstruction of 20th Street between Franklin and Wash.
- 1915 Mar 1 Letter signed A.J. Gerhard, 4521 Duncan Ave., St. Louis, to Perkinson Construction Co., 3237 Carter Ave., St. Louis. Encloses check for payment of special tax bill on 20th Street between Franklin and Wash Streets. "Tax is against estate of Elizabeth Gerhard."
