- 1921 Apr 26 Stock certificate of A.L. Deibel for 3 shares of The Bankers Trust Company of St. Louis.
- 1921 Oct 20 Stock certificate of K. Scheller for 121 shares of the Associated Producing and Refining Corporation, St. Louis, Missouri.
