BIOGRAPHICAL SKETCH

The biographical information here is intended only to give major dates in Grant's life for reference purposes. For additional information, researchers should consult the extensive biographies or other published sources.

Ulysses S. Grant was born April 27, 1822, in Point Pleasant, Ohio, to Hannah Simpson and Jesse Root Grant, and was baptized Hiram Ulysses Grant. Known as Ulysses from infancy, due to a mix-up by the congressman who nominated him to West Point, he was appointed to the military academy as Ulysses Simpson Grant and the adjutant there refused to correct the error. Grant attended West Point from 1839 to 1843 and served in the Mexican War from 1844 to 1847. On August 22, 1848, he married Julia Boggs Dent, the young woman he had met while stationed at Jefferson Barracks, St. Louis, 1843-1844. Their marriage produced four children: Frederick Dent Grant (1850-1912), Ulysses Simpson Grant, II (1852-1929), Ellen Wrenshall Grant (1855-1922) and Julia Root Grant (1858-1934).

Grant is best known for his Civil War military service during which he rose in rank from colonel of an Illinois regiment to command of all Union armies. Following the war, Grant served briefly as secretary of war and was elected president of the United States in 1868. He served two terms as president, until 1876. After leaving office, he settled in New York and began his memoirs, which were published posthumously in 1885 and 1886. U.S. Grant died of throat cancer on July 23, 1885.

SCOPE AND CONTENT NOTE

The Ulysses Simpson Grant Collection is an artificial, or subject-based, collection comprising a variety of documents that have been placed in this collection over the years due to their common subject matter (i.e., Ulysses S. Grant). The collection is arranged in the following series: **Ulysses S. Grant Series**, **Grant-Dent Family Series**, and **Reference Series**.

The **Ulysses S. Grant Series** includes items dated 1858-1885, and consists primarily of correspondence to and from Grant. The series includes eight documents relating to the Civil War and a few items relating to his presidency. Most of this material has been published in the series titled *The Papers of Ulysses S. Grant*.

The **Grant-Dent Family Series** includes items dated circa 1885–1959, and comprises material written to or by members of the Grant or Dent families.

The **Reference Series** includes original documents that were collected because they contain information about Grant and typescript copies and reproductions of Grant-related items.

When the collection was processed in 1999, several items were transferred to the Missouri Historical Society Library and other collections in the Missouri Historical Society Archives. These items are listed in the separation record at the end of this inventory.

Notations such as “Vol. 1/345” that follow an entry in this inventory are references to the volume and page number of *The Papers of Ulysses S. Grant* in which the document has been published. Notations in brackets such as “[gift of William K. Bixby]” that follow an entry refer to acquisition information. A list of Ulysses S. Grant documents found in other collections in the Missouri Historical Society Archives appears at the end of this inventory.

The following abbreviations have been used in this inventory:

AD Autograph Document unsigned (an unsigned document in the hand of the author).

ADS Autograph Document Signed (a document signed by and entirely in the hand of the author).

AL Autograph Letter unsigned (an unsigned letter in the hand of the author).

ALS Autograph Letter Signed (a letter entirely in the hand of and signed by the author).

ANS Autograph Note Signed (a brief or informal letter or message, often fragmentary, entirely in the hand of and signed by the author).

- 1861 Dec 2 ALS John A. Rawlins (for U.S. Grant), Cairo, Illinois, to L.F. Ross. Ross will be governed by enclosed orders. Grant agrees with demand for whiskey but all is prohibited from landing between Cape Girardeau and Bridge Point. 1 page. [purchased from Forest H. Sweet, January 13, 1953]
- 1862 May 11 AL U.S. Grant, Headquarters, Army of the Tennessee, to Henry Halleck. Since Special Orders relieved him from command in the field, he feels that censure was implied, and it is necessary to ask for full restoration or to be relieved entirely from further duty in this department. Contemporary copy. 2 pages. Vol. 5/114-5
- 1863 Nov 20 ALS Braxton Bragg, Army of the Tennessee in the field, to U.S. Grant. Concerning Mrs. General Helm and Mrs. Bruce passing through his lines. 1 page. Vol. 9/378n. (The citation in the *Grant Papers* refers to copies in other repositories, but the Missouri Historical Society document appears to be the original.) [gift of William K. Bixby]
- 1864 Jan 10 ANS U.S. Grant, Memphis, Tennessee, to W.A. Arnold. Directions for sanitary boat. 1 page. [gift of Stella Dempewolf, 3656 Fairview; accession number 58-0094]
- 1864 Aug 4 ALS U.S. Grant, City Point, Virginia, to A. Lincoln. "Your dispatch of 6 p.m. just received. I will start in two hours for Washington and spend a day with the Army under Gen. Hunter." Marked "(Cipher)" and "copied." Vol. 11/360n

- [1864] Aug 12 ALS U.S. Grant to Halleck. Grant gets constant reports of an intention of the rebels to land at Point Lookout to arm the prisoners to aid their escape. He does not think the plan feasible but probably they should be removed to places further north. Marked "cipher" and "copied." 1 page. [gift of William K. Bixby]
- 1864 Sept 26 ALS U.S. Grant, City Point, Virginia, to W.T. Sherman. Better to drive Forrest from Middle Tennessee as a first step. When a movement is made on any part of the sea coast he will advise. If Hood goes to the Alabama line it may be impossible for him to supply his army. Marked "Cipher" and "Copied." 1 page. Vol. 12/211
- 1865 May 29 ALS U.S. Grant, Washington, D.C., to J. Russell Jones. Sends six hundred dollars to credit his account. Hopes to get out to Fair and is determined to present "Old Jake" to the "Fair." He has promised Mrs. Sherman she shall have disposal of him as he is a splendid saddle horse. Vol. 15/105 [accession number 58-0038]
- 1865 Sept 19 ALS U.S. Grant, St. Louis, Missouri, to Father [Jesse Root Grant]. Will leave here Friday for Cincinnati. Gov. Morton of Indiana made him promise to visit Indianapolis before returning to Washington but starting so late he will not be able to. Julia and the children are well. 2 pages. Vol. 15/324 [accession number 72-0023]
- 1866 Mar 10 ALS W.T. Sherman, St. Louis, Missouri, to U.S. Grant. Against choosing Gen. P. St. George Cooke for command of Dept. of Platte; suggests Gen. W. Scott instead. 2 pages. Vol. 16/97n [accession number 61-0007]
- 1868 Handbill. "Let Us Have Peace! To the Polls for Grant & Colfax" with eagle picture. For president, U.S. Grant, for vice president, Schuyler Colfax, followed by the Republican slate. 1 page.
- 1868 Circular. "The Presidential Campaign." Address of the Central Grant Club of St. Louis to the Republicans of Missouri. Lists twelve reasons to nominate Grant. From the Executive Committee. 1 page.
- 1868 Jan DS J.E. Pearce, St. Louis, Missouri, to Milo Blair. Printed form letter from Headquarters, Central Grant Club. Asks Blair to organize a local Grant Club. 1 page.
- 1868 Sept 11 ALS U.S. Grant, Galena, Illinois, to George K. Budd. Budd's favor of 3rd September received. Previous letter asking for position for Capt. Wade also received. Grant has sent it to Washington with an endorsement. 1 page. Vol. 19/35
- 1869 *Missouri Democrat* newspaper extra. Grant's inaugural address. 1 page.

- 1869 Mar 29 DS David Wagner, Philemon Bliss, Warren Currier, St. Louis, Missouri, to U.S. Grant. The undersigned have great pleasure in recommending George P. Strong of this city to be appointed United States circuit judge for the district embracing the state of Missouri. 1 page. Vol. 19/403 [accession number 57-0162]
- 1869 Apr 23 ALS J.W. McClurg, City of Jefferson, Missouri, to U.S. Grant. Recommend Benjamin F. Loan for appointment as judge of the 8th U.S. Judicial Court. 3 pages.
- 1869 July 11 ALS Carl Schurz, St. Louis, Missouri, to U.S. Grant. Received telegram from George Earle stating the president would appoint James Hunter postmaster at St. Joseph unless Schurz could make a good objection. As to Republicans of St. Joseph desiring appointment of somebody else, he refers to a petition in favor of Major Drumhiller recently sent out. 3 pages. Vol. 19/514-5 [accession number 59-0060]
- 1870 Jan 8 ALS Charles D. Drake, Washington, D.C., to U.S. Grant. If nomination of Judge Hoar comes to a vote, he expects to vote for confirmation. 1 page. Vol. 20/55n
- 1870 Jan 11 ALS [John A.] Logan, Washington, D.C., to U.S. Grant. Concerns the transfer of an unnamed lieutenant who wants to move to the Washington Territory. Logan will call on the president today to discuss the matter. 1 page. [gift of William K. Bixby]
- 1870 Sept 22 ALS U.S. Grant, Long Branch, New Jersey, to Charles W. Ford. Wishes Ford to go to Carondelet and see the man who lives on the piece of land, terminate his lease and make new arrangements to rent it for next year. Vol. 20/278 [purchased from Ben Bloomfield, 65 University Place, New York, December 3, 1951]
- 1872 Pamphlet. "More Than One Hundred Reasons Why General U.S. Grant Should Be Re-elected President of the United States on November 5th, 1872." Published in Philadelphia and signed on back by U.S. Grant. 36 pages. [accession number 67-0010]
- 1873 Oct 25 U.S. Grant, Washington, D.C., to Judge John F. Long. "Our old friend Ford is gone!" Reminiscences. 3 pages. Vol. 23/231
- 1874 Jan 5 ALS U.S. Grant, Washington, D.C., to Admiral Worden. Letter of introduction for Judge Treat, who visits the academy to see a nephew who is now a cadet. 1 page.
- 1875 July 19 ALS W.B.W. Barnard, Kirkwood Hotel, St. Louis County, Missouri, to U.S. Grant. Neither Henderson or Dyer like a bone in Grant's body. Says that the

newspapers attempt to tarnish his character and he is surrounded by intriguers trying to undermine him. He has three cabinet members of this stamp: Bristow, Pierpont and Sewell. Contemporary copy, marked "Personal." 6 pages. [accession number 74-0024]

- 1875 Sept 26 ALS Hamilton Fish, Washington, D.C., to U.S. Grant. Should a vacancy occur in the secretaryship of the Interior, assistant secretary may act as successor but the statute says it must not be temporarily filled for longer than ten days. Fish will need to sign a commission before he goes to Colorado. 1 page. [accession number 57-0054]
- 1876 Jan 19 ALS W.T. Sherman, St. Louis, Missouri, to U.S. Grant. Requests written criticism of his (Sherman's) memoirs to be included in second edition. 2 pages. [accession number 64-0022]
- 1877 May 9 ANS U.S. Grant, Philadelphia, Pennsylvania, to Jesse [Grant]. "You young worthless. I expected to see you at your Grandma's. You will not now see her before sailing for Europe. You know we sail on the 17th and if you should not be here you will be left without visible means of support. I shall make no arrangements for you in our absence." 1 page. [purchased from Ben Bloomfield, New York, November 26, 1952]
- 1879 Dec 25 ALS U.S. Grant to John F. Long. Grant expresses sorrow upon hearing of Long's suffering. Tells Long to "present your grand daughter, Nellie Grant, a silver cup from Nellie Grant Sartoris at my expense." Discusses possibility of selling his [Grant's] farm. Grant is departing soon for Cuba and Mexico, and suggests that Gen. Harney should join him there. 4 pages. [accession number 63-0007]
- 1881 Oct 24 ALS W.S. Harney, 3518 Washington Ave., St. Louis, Missouri, to U.S. Grant. Harney states that Grant was kind enough to appoint Isaac H. Sturgeon collector of internal revenue at St. Louis, upon Harney's recommendation. Harney now requests that Grant recommend that President Arthur retain Sturgeon in this position. Contemporary copy. 3 pages.
- 1881 Oct 28 ALS U.S. Grant, New York City, to W.S. Harney. Already put in a word on behalf of Mr. Sturgeon. Sorry to hear Harney's sight is growing weak. 1 page.
- 1884 June 26 ALS U.S. Grant, Long Branch, New Jersey, to James Campbell. Has Campbell's letter offering him \$75 per share for two shares of St. Louis Agricultural & Mechanical Association stock. He will gladly sell but cannot find the certificate. Even the small sum is of great importance now when everything is being swept from him. 2 pages. [gift of James Campbell, 1921]
- 1884 Sept 13 ALS F.D. Grant (for U.S. Grant), Long Branch, New Jersey, to John S. Griffin. He expected to get some photographs and intended sending one to

Griffin but he has not yet received any. Thanks Griffin for his kind remarks. 1 page. [gift of Mr. C.M. McDonald at the suggestion of James Espy]

- 1884 Dec 18 AL [U.S. Grant]. Cannot make definite arrangements until his book is near enough completion to feel sure it can be completed even if his health should further fail. He will receive proposals and will accept the most favorable one, consulting G.W. Childs in the matter. 2 pages. (Removed from a copy of *Personal Memoirs* by Ulysses S. Grant. Pasted on the reverse side of a lithograph of U.S. Grant, and ANS [Andrew Carnegie] to Mr. C. "I went to see General Grant today. He has a bad throat & is prohibited from talking. The enclosed explains the situation. I don't think Mr. Childs will approve . . .") 4 pages. [gift of Mrs. John Gundlach]
- 1885 July 24 *St. Louis Globe-Democrat* newspaper issue, Vol. 11, No. 62. Contains news of U.S. Grant's death. 2 sheets of newsprint. [gift of William K. Bixby] **Oversize**
- [1885 July] Mayor's proclamation (on newsprint) suspending business in the city of Rockville on August 8, 1885, in honor of the recently deceased U.S. Grant. 1 page.

- 1899-1966 Wedding invitation, correspondence and newspaper clippings regarding Princess Cantacuzene, the former Julia Dent Grant. 10 items.
- 1926 Dec 6 ALS U.S. Grant, III, to William K. Bixby. Requests copies of correspondence of his grandfather relative to the "Whiskey Ring" investigation. (Given to the Missouri Historical Society as an example of Grant's signature, which is very much like his grandfather's.) [gift of William K. Bixby, 1926]
