BIOGRAPHICAL SKETCH

Luther Ely Smith was born June 11, 1873, in Downer's Grove, Illinois, and raised in Freehold, New Jersey. A lifelong Republican, he spent his adulthood in the predominantly Democratic city of St. Louis, where, despite his anomalous politics, he emerged as a prominent attorney and civic leader. The son of Luther Rominor Smith and Adeline Ely, the younger Smith was heir to a tradition of Northern Republican reformism. His father, most notably, was a Reconstruction Republican who relocated to Alabama following the Civil War and served as a circuit court judge for twelve years before returning north.

Luther Ely Smith's father, Luther Rominor Smith, was born March 2, 1838, in Coleraine, Massachusetts, and graduated from Amherst College in 1859 where he studied law. In 1862, he enlisted in the Union army, served for three years, and mustered out in 1865 as captain of Battery I of the 1st Michigan Artillery. After the war the senior Smith relocated to Alabama where he purchased a plantation in Choctaw County, Alabama. There he served as a member of the Reconstruction Alabama Constitutional Convention in 1867, and in 1868 was appointed judge of the Seventh Judicial Court, a position which he held until 1880. His tenure as a Republican judge in the South during and after Reconstruction has been described as "extremely delicate, hazardous, and difficult."¹

From 1883 until his death in 1913, Judge Smith resided in Washington, D.C., where he was employed by the U.S. government. He served initially in the Law Department of the General Land Office, but transferred soon thereafter to the Office of the Assistant Attorney General for the Department of the Interior, where he served in various legal capacities, including a term as chief of the Indian Territory Division of the Interior Department. Luther Rominor Smith married Adeline (Addie) Ely of Freehold, New Jersey, on August 16, 1871, by whom he had a son, Luther Ely, and a daughter, Helen. After the death of Adeline and six-month-old daughter Helen in 1875, Smith's son, two-year-old Luther Ely, was brought north to the Ely family farm in Freehold. Remaining behind in Alabama, Luther Rominor Smith married his second wife, Helen

Ely (Nellie), the sister of his first wife, sometime prior to 1880.

Like his father, Luther Ely Smith was raised and educated in the north. He graduated from Williston Academy in Easthampton, Massachusetts, in 1890, and received his A.B. degree from Amherst College in 1894. At Amherst, the younger Smith developed friendships with classmates Calvin Coolidge, Harlan Fiske Stone, Dwight Morrow, and Wiley Rutledge, which would serve him well during his adulthood. After graduation from Amherst, Smith moved to St. Louis where he attended Washington University School of Law, earning his LL.B in 1897.

Following his graduation from Washington University, Smith found employment at the Smith Preparatory Academy in St. Louis as an English teacher. With the outbreak of the Spanish-American War in 1898, he enlisted with the 3rd United States Volunteer Engineers, was stationed both in Georgia and Cuba, and mustered out with the rank of lieutenant a year later. On August 17, 1899, Smith began the practice of law in St. Louis. He served with a series of firms: Gilliam and Smith (1900-1904), Klein and Smith (1904-1908), Luther Ely Smith (1908-1913), Smith and Percy (1913-1937), and Luther Ely Smith and Associates (1937-1951). In the firm of Luther Ely Smith and Associates, Smith was in practice with his son, Luther Ely Smith, Jr., among others. His law practice was briefly interrupted when Smith again volunteered for military duty during World War I, serving as captain of field artillery.

Throughout his career, Smith used the practice of law, his political connections, and personal relationships as tools through which he attempted to implement progressive ideas regarding social change. The list of progressive causes with which Luther Smith identified touched every facet of the city's complex fabric. Smith was chairman of the City Commission from 1916 to 1922 and chairman of the Council of Civic Needs from 1929 to 1938. He was an organizer of the Open-Air Playground Committee, which resulted in St. Louis's first municipal playgrounds. Smith worked for a new city charter and campaigned zealously for bond issues to improve the city. In 1941 Smith was appointed to the city's first Civil Service Commission, serving as its vice-chairman until 1945, and as its chairman from 1945 to 1950. Smith was secretary of the St. Louis Pageant Drama Association, which produced the Pageant and Masque on Art Hill in 1914 and which eventually gave rise to the St. Louis Municipal Opera.

The civic enterprise for which Luther Ely Smith is best known is the Jefferson National Expansion Memorial, of which the Gateway Arch is a part. Smith adopted the idea for a St. Louis riverfront memorial from a similar memorial erected in Vincennes, Indiana. It was while Smith was a member of the federally funded George Rogers Clark Sesquicentennial Memorial Commission that he realized not enough attention had been given to the builders of the nation's west. Memorials had been erected to early colonial persons and events, but all in the east. Since it was Thomas Jefferson who executed the Louisiana Purchase, a memorial of westward expansion bearing his name on the decaying St. Louis riverfront seemed logical.

The idea aroused the attention of city officials and the City Planning Commission who were looking for a solution to the problems of the St. Louis riverfront, where downtown businessmen were losing business and watching their property values rapidly decline due to the general

deterioration of the downtown and riverfront areas. Both city planners and downtown businessmen were eager for any plan that would improve business conditions. The attraction of Smith's plan, inspired as it was by the George Rogers Clark Memorial, was that it might be financed in part by federal money, thus reducing the burden on St. Louis taxpayers. A lack of sufficient local funding had been the major stumbling block to other improvement plans. Smith's suggestion took root so deeply that in 1935 St. Louis voters voted to pay \$7,500,000 to have the idea transformed into reality. Luther Ely Smith was appointed chairman of the Jefferson National Expansion Memorial Association, a position he held until his death in 1951. Although Smith was involved in all phases of planning the memorial, he did not live to see the project completed. The onset of World War II, conflicts over railroad right-of-ways on the riverfront, and funding difficulties delayed the completion of the memorial, originally targeted for 1951, until 1964.

In the service of the state of Missouri, Smith participated in the development of the non-partisan court plan, working as chairman of the state organization committee from 1939 to 1941. In 1941, he received the St. Louis Award for civic leadership for his activities in the statewide referendum campaign.

In addition to Luther Ely Smith's involvement in politics, civic affairs, and business, he was also deeply involved with his family, attending family gatherings and vacationing whenever he was free to do so. Smith married SaLees Kennard, daughter of Samuel Kennard of St. Louis, on November 17, 1909. They had three children, Adeline (born November 10, 1910), Luther Ely, Jr. (born June 16, 1912) and SaLees Kennard (born March 17, 1915). Adeline married Ingram Boyd, Jr., of Boyd's Department Stores, and with her husband aided greatly in raising funds for the riverfront memorial project. SaLees married Dr. John Seddon, a prominent St. Louis doctor. Luther, Jr., married twice, first to Bernice Smith whom he later divorced, and then to Ruth Olga von Prittwitz und Gaffron of Germany. Luther Ely, Jr., an attorney, was associated with his father-in-law's practice. Luther Ely Smith, Sr., died April 2, 1951, at the age of seventy-seven.

SCOPE AND CONTENT NOTE

The Luther Ely Smith Papers consists primarily of his personal, family, and business records. The collection also documents the life of his father, Luther Rominor Smith, a Reconstruction Republican judge and plantation owner in Alabama and later government official in the U.S. Department of the Interior in Washington, D.C., as well as his own career and family life as a prominent Republican attorney and civic leader in St. Louis.

The bulk of the collection, consisting of Luther Ely Smith's personal and business papers, spans the years 1888 to 1951, with most of the material dating from the 1930s and 1940s. Luther Ely Smith's papers include extensive correspondence relating to a variety of national and local civic and political matters with which he was concerned, including the St. Louis Pageant and Masque production of 1914, the American Friends of Spanish Democracy, the American Civil Liberties Union, the Missouri Bar Association, the Jefferson National Expansion Memorial, and the St. Louis Civil Service Commission. The papers also include private Smith family correspondence. In addition to correspondence, the Luther Ely Smith material includes legal briefs, court records,

letterbooks of legal correspondence, newspaper clippings, and scrapbooks.

The collection also contains the papers of Luther Rominor Smith, Luther Ely Smith's father, dated 1821, and 1846 to 1923. These papers include the 1821 will of Luther R. Smith's father, Rominor Smith; Civil War correspondence and records of Luther R. Smith during his service with the 9th Michigan Battery; diaries and memoranda books from throughout his life; legal notes, briefs, and professional correspondence; newspaper clippings and personal correspondence regarding the Ku Klux Klan in Alabama and the persecution of Smith by them while he was a circuit judge there. The collection also includes correspondence and financial records regarding the operation of Judge Smith's Choctaw Plantation in Alabama, and personal correspondence between Luther R. Smith and his first wife, Addie Ely, and correspondence of his second wife, Helen (Nellie) Ely.

The papers of Luther Ely Smith are arranged in four series: correspondence, printed material, scrapbooks, and letterbooks.

Series I: Luther Ely Smith Papers, Correspondence (1888-1951; no date). Luther Ely Smith's correspondence files contain both correspondence and related documentation generally arranged alphabetically by name of correspondent or topic. Correspondence on the same topic or with the same person has then been arranged chronologically within the alphabetical framework. Reflecting the original organization of Smith's files, this arrangement results in the inclusion of his business, civic, and personal correspondence and related documentation in a single series of records. This series includes Smith's family correspondence, records documenting Smith's work with the St. Louis Civil Service Commission, and his involvement with the Jefferson National Expansion Memorial project. Most of the records of his law practice are not included.

Series II: Luther Ely Smith Papers, Printed Material (1928-1951; no date). This series consists of items that appear not to relate to topics covered in his correspondence files. They include a brochure of Bellefontaine Cemetery, newspaper clippings, and membership cards.

Series III: Luther Ely Smith Papers, Scrapbooks (1890-1907). This series consists of five volumes that reflect Luther Ely Smith's early interests and involvements in St. Louis. Providing an excellent overview of the political and social climate of turn-of-the-century St. Louis, these scrapbooks contain political memorabilia, especially in regard to St. Louis politics and the activities of the Republican party, and material relating to social and political clubs in St. Louis.

Series IV: Luther Ely Smith Papers, Letterbooks (1899-1907). This series consists of three volumes of letterpress correspondence of Luther Ely Smith's law practice, during which Smith was associated with the firms of Gilliam and Smith and Klein and Smith. These volumes, plus a few items filed in the correspondence files, appear to constitute the main portion of Smith's legal records in this body of papers.

The Luther Rominor Smith papers are arranged in four series: correspondence, printed material, Nellie Ely Smith correspondence, and memoranda books and diaries.

Series V: Luther Rominor Smith Papers, Correspondence (1821; 1846-1895; no date). This series consists primarily of the family and business correspondence of Luther Rominor Smith. It includes the 1821 will of his father, Rominor Smith; Civil War correspondence and records; correspondence with his first wife, Adeline (Addie) Ely; correspondence related to his legal career in Alabama, the activities of the Ku Klux Klan, and his plantation in Choctaw County, Alabama, and other business matters. This correspondence is generally arranged chronologically.

Series VI: Luther Rominor Smith Papers, Printed Matter (1865-1914). Arranged by type of document, this series consists of accounts, bank drafts, bills, newspaper clippings, military commissions, receipts, booklets, and printed reports related to a variety of matters, including personal and business finances, the Choctaw County, Alabama, plantation, and his military and legal careers.

Series VII: Luther Rominor Smith Papers, Nellie Ely Smith Correspondence (1876-1923; no date). This series includes biographical material on Adeline (Addie) Ely Smith, Luther R. Smith's first wife; and the personal correspondence of her sister, Helen (Nellie) Ely Smith, Luther R. Smith's second wife. The Nellie correspondence, addressed to Luther Rominor Smith, begins upon the death of Addie, and continues into and through her own married life. Arranged chronologically, this series includes discussions of the upbringing of Luther Ely Smith after the death of his mother.

Series VIII: Luther Rominor Smith Papers, Memoranda Books and Diaries (1869-1913). Arranged chronologically, this series consists of bound volumes of accounts, memoranda, addresses, and diaries maintained by Luther R. Smith. These volumes relate to his personal and business finances and legal and professional affairs, and include an 1873 diary that recounts the birth of his son, Luther Ely Smith, and a 1905 trip diary.
