HISTORICAL SKETCH

The Community Council of St. Louis, established in 1911, reorganized in 1937 as the Social Planning Council. It was supported by the United Charities, Inc. The council was a voluntary association made up of over 95 public and private social agencies for the purpose of studying social conditions; analyzing and stimulating social needs and the community resources necessary to meet them; insuring that the health and welfare needs of people are adequately satisfied and promoting cooperation, higher standards, efficiency and coordination among the agencies of the community.

SCOPE AND CONTENT NOTE

The Collection contains monthly typescript minutes and financial statements of the Board of Directors of the Social Planning Council, dated October 1941 to December 1945.

These minutes include reports of hospitals, orphanages, nursing homes, camps and several other types of institutions in St. Louis City and County.
